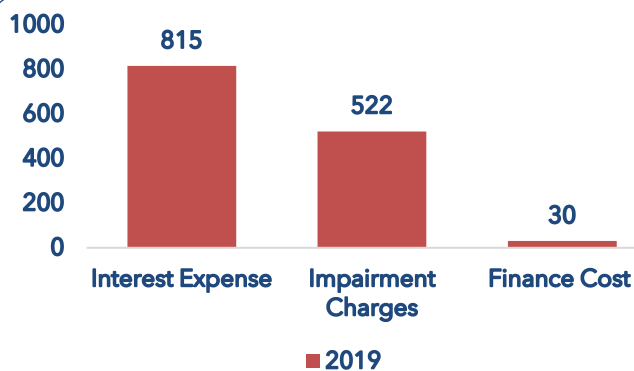
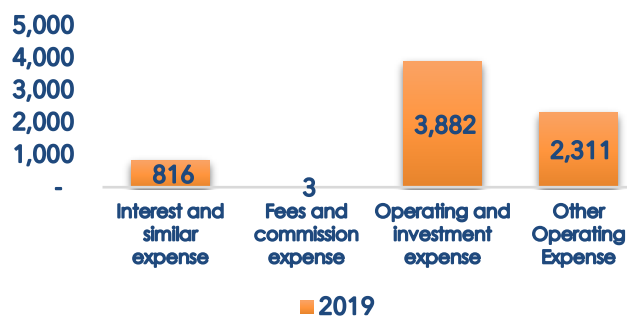

Gross Operating Expense N Million

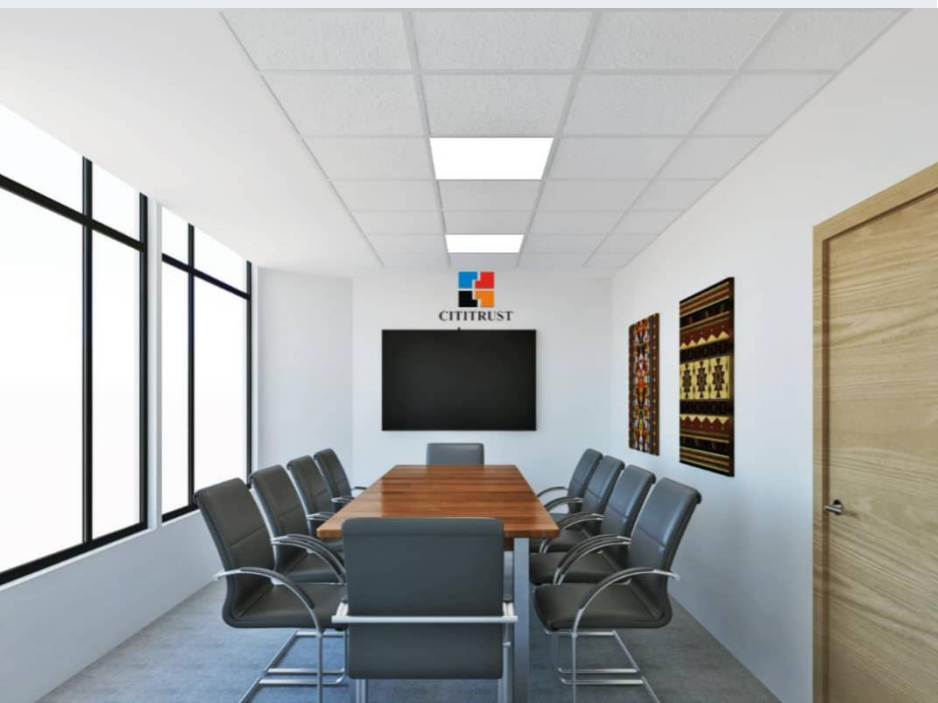


Corporate Actions
